research funds

Visit www.skandia.co.uk to find out all the latest information on specific funds, including fund prices, fund performance and fund factsheets. This is useful if you are thinking of changing your fund choice and want some background information before you speak to your financial adviser.

find out how your investment is performing

Visit the Client Extranet and you can track your investment's progress by getting an instant valuation. This will tell you:

- your fund unit prices
- the total value of your portfolio
- the value of each fund.

change your investment strategy

Skandia allows investors to switch between funds, which is currently free of administration charges. The Client Extranet gives you control over this, allowing you to change your fund choice at any time. Go online and you can:

- switch specific funds, or all your funds, into a new fund selection
- redirect your future monthly direct debit payments into a new fund selection (if applicable).

registration

To register for Skandia's secure Client Extranet, follow these simple steps.

1. Go to www.skandia.co.uk
2. Click on 'UK Client Extranet' on the right-hand side of the screen.
3. Click on 'register'.
4. Complete the online registration form, entering your policy details and personal details, and choosing your username and password. If you have more than one Skandia policy, you can register them all here.
5. Choose to either print the Extranet Terms and Conditions, or request they be sent to you.
6. Sign the Extranet Terms and Conditions and send them to Skandia.
7. On receipt of your signed Terms and Conditions we'll process your extranet registration and e-mail you to let you know your registration is complete.

logging on

Once you are registered for our Client Extranet, this is how you log on:

1. Go to www.skandia.co.uk
2. Click on 'UK Client Extranet' on the right-hand side of the screen.
3. Enter your username and password, then click on 'logon'.
